Minutes: At the invitation of Cllr David Somers (Deputy Mayor), the Committee

Clerk delivered a summary of the work undertaken as a result of the resolutions and action points from the previous meetings as follows;

- The Committee Clerk has requested a quote to plant a tree at Blackhorse Road common and will chase for a reply as none has been received.
- Councillor Sunderland has advised that the planters in Emerson Way have been painted and re-planted.
- A survey has been emailed to the allotment tenants about their use of herbicides and pesticides and a lot of them have completed the survey.
- Allotments evening 17 Nov; Chris Sunderland is available to talk about the work of the Friends of Emersons Green Park. An interpreter has been booked.
- MPRC signage; No Parking and Bye Law signs have been ordered. A quote will be obtained for the other signs.
- Hedges at the allotments; this site visit could not take place because of the mourning period following the death of HM Queen Elizabeth II. The visit will be rescheduled.
