PURPOSE OF REPORT

The purpose of this report is to provide Councillors with official advice and recommendations from the Town Councils proper officer for the following meeting:

Open Spaces Committee, The Council Chamber of Emersons Green Town Council, 30th May 2023 commencing at 1900hrs.

AGENDA ITEM: OS_2023.006 Outstanding Items from the previous minutes.

To report that:

- The vegetation and debris on the land at the rear of 51 Meadgate has been cleared.
- The replacement Field Maple at Blackhorse Road Common has been replanted in the correct position.
- The Friends of Emersons Green Park have put new plants in the planters in Emerson Way.
- Some of the Open Spaces committee councillors met with Dan Marchant, SGC, and his colleague, to consider options for the car park at the allotments. Their thoughts are awaited.
- New "No Parking" and Bye Law signs have been installed at Vinney Green and Blackhorse Road commons. Other signs to replace ones with MRPC have been received and will be installed at Green Lane and Rodway common.

LEGAL POWER OR DUTY TO ACT

RECOMMENDATIONS, CONDITIONS, AND OTHER CONTROLS

- To note that the common has the benefit of a management scheme run by South Gloucestershire Council.
- That members debate the matter.

REASONS FOR RECOMMENDATION

- Corporate Priority 1; Improve the management and maintenance of the parks & open spaces managed by the Council.
- The management of this land is not in the Town Council's current strategic plan.

FINANCIAL IMPLICATIONS & RISKS

- The present office staff do not have enough time to investigate options for the Common.
 Possibilities include the investigation being; done by a Councillor or Working Group; outsourced; done by an Environment Manager once in role.
- There will be legal and other professional costs even to investigate this matter. Quotes will be needed to find out the costs but they are likely to be several thousand pounds.
- Agreement would need to be sought from Full Council has Open Spaces does not have a budget for legal and other professional costs.
- Focusing resources on this land would reduce resources available for the land the Town Council owns.
