The access onto Cossham Street is inadequate to handle the expected volume of traffic generated by the proposed development. As a 'B' road, it already struggles with the current traffic flow, particularly due to its proximity to local amenities. Furthermore, the access road is situated near an already heavily used football ground, exacerbating safety and traffic concerns.  The proposed estate is likely to become a key walking route for children traveling to school. Without a designated pedestrian footpath throughout, this poses significant safety risks and could result in preventable accidents. Additionally, the development would result in the loss of valuable green space, negatively affecting local wildlife and reducing biodiversity in the area.  Should the development proceed, it is crucial that the proposed access road incorporates sufficient traffic-calming measures. These should include the installation of bollards to prevent residents and visitors from parking on grass verges, ensuring the safety and usability of the area for all.
